

OFFICIAL CONTEST RULES

NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN. The Contest ("Contest or Drawing") is sponsored by the Municipal Employees Credit Union of OKC ("Me/CU"). This contest is governed by these Official Rules ("Official Rules"). By participating in the contest, each entrant agrees to abide by these Official Rules, including all eligibility requirements, and understands that the results of the Contest, as determined by Me/CU and its agents or representatives, are final in all respects. The contest is subject to all federal, state and local laws and regulations and is void where prohibited by law. This promotion is in no way sponsored, endorsed or administered by, or associated with, Facebook. Any questions, comments or complaints regarding the promotion will be directed to Me/CU, not Facebook.

ELIGIBILITY

- The Contest offer is limited to U.S. residents who are aged sixteen (16) years of age or older.
- Me/CU employees, Board of Directors, Committee members, and all immediate family members are ineligible to participate.
- Me/CU has the right to verify the eligibility of each entrant and in its sole discretion, disqualify any individual from participating in the Contest.
- The Contest is void where prohibited.
- The Contest and these Official Rules will be governed, construed and interpreted in accordance with Oklahoma law.

CONTEST PERIOD

- The Contest begins and ends on the dates notated on the Credit Union's Facebook Timeline. The deadline for entering the Contest is also found on the Credit Union's Facebook Timeline.
- All entries or submissions must be received on or before the time stated.
- Me/CU reserves the right to extend or shorten the Contest in their sole discretion.

HOW TO ENTER

- You must enter the Contest through Me/CU's Facebook Page.
- Entrants must follow all required rules of entry to participate in the contest.
- Rules may include "Liking" a post on Me/CU's Facebook Timeline or commenting on a Timeline as instructed.
- After complying with the instructions and submitting the required information, the entrant will automatically be entered to win.
- You may enter as many times as you wish.
- By entering, entrant agrees to be bound by these Official Rules and by the decisions of Me/CU.

WINNER SELECTION

- All eligible entries received during the Contest Period will be gathered into a database at the end of the Contest Period.
- A certain number of winners will be chosen at random by Me/CU with the number notated on the Credit Union's Facebook Timeline. Some Contests may have as few as one (1) winner but may have more than one as announced.
- The winner(s) will be announced shortly after the Contest Period ends. Announcements and instructions for prize collection will be sent via a Facebook posting on Me/CU's Facebook Timeline.
- The prize and/or prizes shall be selected at the discretion of Me/CU and will be notated on the Credit Union's Facebook Timeline with other applicable information.
- Each entrant is responsible for monitoring Facebook for posts regarding prize notification and/or receipt or other communications related to this Contest.
- If a potential prize winner does not contact Me/CU within 3 days of announcement of the winner, or if the prize is returned as undeliverable after having been mailed or otherwise delivered, that potential prize winner shall forfeit the prize.

FACEBOOK TIMELINE
